**Food Concession Application  
OKTOBERFEST 2013  
October 5th  
Downtown De Kalb, Texas**

Concessionaires must submit their completed application and payment by September 19, 2013. A copy of liability insurance must be included along with copies of Sales Tax and Health Certificate.

Concession placement will be at the discretion of the committee however, you may request a certain space by making application early.

Concessionaires may begin setting up at any time after 5:00 p.m. on Friday, October 4th. No set-up will be allowed before this time. You may set-up on October 5 between 6:00 and 8:00 a.m. however, it is suggested that you arrive October 4th due to heavy traffic on Saturday morning. Please enter the area from Hwy 82, north on Runnels St.

**The OKTOBERFEST COMMITTEE licensed electrician will complete actual electrical hook-ups. Dennis Wandrey will be available after 5 p.m. on October 4th. Please do not attempt to plug your unit into the OKTOBERFEST breaker panels.**

Booths must be manned at all times. Each Concessionaire is responsible for the appearance of their booth space. Each Concessionaire must clean up the space and all litter bagged at the end of the show. A dumpster will be provided for the litter disposal. The fee will be returned at check out. An empty drum will be provided for used cooking oil. Dumping of oil will result in the loss of clean up fee and citation from the City of De Kalb for illegal dumping. Location of the barrel will be pointed out at check in.

**NO PETS will be allowed in the Concessions, or on the festival grounds. Handicapped companions are the only exception.**

If you desire to remain for evening activities, please indicate on the return form. An additional fee will be required. Evening booths must stay in place until midnight. NO VEHICLES will be allowed on Runnels or Bowie St. until 12 midnight. The premises must be cleared by 1:00 a.m.

**OKTOBERFEST RESERVES THE RIGHT TO REFUSE CONCESSION SPACE RENTAL.**

**ABSOLUTELY NO VENDOR WILL BE ALLOWED TO SET UP ON THE DAY OF THE FESTIVAL IF THE OKTOBERFEST COMMITTEE HAS NOT RECEIVED YOUR APPLICATION, ANY VENDOR DOING SO WILL BE ASKED TO LEAVE.**
